RE: VETO OF CERTAIN COUNCIL BUDGET RESOLUTIONS

Dear Councilman Torres:

Pursuant to the authority vested in me by Chapter IV Sec.7(4) (ii) and Chapter X Sec.5 and other applicable sections of the Charter of The City of Hartford, I hereby veto and reduce a number of the Council budget resolutions adopted at the May 19th Council meeting. Additionally, I have reduced my proposed budget by \$6.1 million. I urge you to move quickly to support my proposed reductions to the budget and sustain my vetoes and reductions.

As you know, I am deeply disturbed by the reckless cuts that have been proposed by some members of Council. These cuts will directly harm our neighborhoods, by slashing job creation programs, removing as many as 70 police officers from our streets, gutting foreclosure assistance and jeopardizing our "A" bond rating. Further, the Council cuts to the Board of Education budget will cause serious harm to the progress we have made in education. At the same time the Council is slashing police and other core city services, the Council has increased its own budget by sixty-two percent (\$350,000). It defies belief that the City Council in these difficult times would create a budget that put its own needs before public safety, job creation, homeownership and education. I do not believe the people of Hartford would support the values and priorities laid out in the budget Council has proposed.

I have vetoed a number of portions of the Council budget. However, I would like to highlight some of the items that deserved Council support:

- Cutting the Board of Education by \$3 million. This cut undermines the significant progress we have made in student achievement by removing instructional resources from the classroom.
- Slashing the Police Department by \$500,000. Not only does this cut take officers off the street it disqualifies the city from receiving funding for 40 officers from federal stimulus funds.

- Laying Off 120 City Employees Including Police. By directing \$6.4 million in additional payroll cuts, no less than 120 employees will be laid off including police officers.
- Chopping \$600,000 from the Arts Job Creation Program. This cut means as many as 70 fewer Hartford jobs will be created through the Arts Jobs program. This is the wrong time to block job creation.
- Eliminating the Home Foreclosure Assistance Program. In difficult times, we want to keep families facing foreclosure in their homes. By cutting the foreclosure assistance program Council has cut an important lifeline for our homeowners.

My vetoes and reductions have brought my proposed budget down by \$6.1 million while still maintaining public safety, and supporting homeownership, education and job creation. Further, I believe that it is still possible that city unions will come forward to offer concessions of at least \$3.2 million to help relieve the financial burden on the city in the near term. I believe it is imperative the Council act to adopt this responsible budget and keep our city government working to make our city better for all who live and work here.

I also would like to remind you that the Council has an obligation to pass a budget by the end of this month. Failure to act will result in last year's expense budget going into effect plus all increases in debt service, pension and contractual expenses. Further, we will use current revenue estimates to determine the mil rate. The resulting budget will be considerably higher than \$547 million and the mil rate increase could be as high as sixteen mils.
