Mayor Segarra Announces Plan to Extend Revaluation Appeal Process

This year's tax legislation, while a relief to commercial taxpayers, has made the revaluation process very complex To alleviate some of the confusion and to assist all property owners, Mayor Segarra asked the Assessor to ensure the validity of revaluation and property values and extend the deadline to file revaluation appeals. The property tax legislation, passed in 2011 by the Connecticut General Assembly, continues the practice of assessing residential property at a lower percentage of value than commercial property. Mayor Segarra, First Lady Cathy Malloy Acknowledge Jobs Grant Program

In February, Mayor Segarra and Greater Hartford Arts Council Chief Executive Officer Cathy Malloy joined workers at the Isham-Terry House to acknowledge the job creation efforts of the 2012 GHAC Hartford Arts & Heritage Jobs Grant. The Isham-Terry House an Italianate villa purchased by Dr. Oliver Isham in 1896, was occupied by Isham's sisters Julia and Charotte until the 1970s. Despite the changing times, the sisters made very few changes in the house, thereby preserving its historic character. The revitalization was funded in part through an award to Connecticut Landmarks, one of 16 recipients of the Arts & Heritage Jobs Grant. In addition to restoring one of Hartford's historical treasures, the Arts & Heritage Jobs Grant will provide job opportunities for local small businesses and residents. Last year, the grant program resulted in the retention of three jobs, the expansion of 12 jobs and the creation of 109 new jobs, including 26 youth employment positions. Additionally, grantees purchased more than \$149,000 worth of materials and services from Hartford businesses Established by the City of Hartford and administered by the Arts Council, the Hartford Arts & Heritage Jobs Grant Program provides funds to arts and culture programs and projects. As a result, these entities employ local residents, create business opportunities and promote economic development across sectors. The Hartford Arts & Heritage Jobs Grant will fund a total of \$370,138 for these efforts through the Greater Hartford Arts Council, a national leader in connecting the public to arts and entertainment.

Mayor Delivers State of the City Address

In March, Mayor Segarra delivered his State of the City address, focusing on the City's truths, its achievements and its challenges ahead. Specifically, the Mayor spoke about th4 newly appointed Hartford Board of Education members, the success of the iQuilt Presents Winterfest, and the affirmation of the City's bond ratings, which predict a stable outlook for Connecticut's Capital City. He also discussed the difficult fiscal situation facing the City in the next fiscal year, created in part by changes to the City's tax structure and a significant decline in property values. City administrators and the Mayor will be exploring a host of options to close the budget gap and will communicate those changes to the public in the most transparent way possible. "We must all commit to working in the best interest of our citizens to curtail spending while ensuring the provision of basic services and preserving quality of life," Mayor Segarra said.

Tax Preparation Services for Working Families

taxes would have risen dramatically. The legislation also altered the City's tax structure and caused uncertainty among property tax owners. To ensure that the community fully understands the changes and potential impacts, Tax Assessor John Phillip and Tax Collector Marc Nelson will conduct community outreach, providing printed materials in public libraries, City departments that are frequented by the public and various businesses. In addition, two community presentations will be held in early March. several Volunteer Income Tax Assistance (VITA) sites in the City, which can provide free tax preparation services, including electronic filing and direct deposit. The sites are staffed with IRS trained and certified volunteers who can assist families with preparing and submitting their federal and state returns, and determine their eligibility for tax credits and refunds, including the new state Earned Income Tax Credit. WTAsites are operated by the Hartford Asset Building Collaborative under the management of Co-opportunity. Filers who visit these sites can also obtain information on assetbuilding and assistance in completing the Free Application for Student Aid (FAFSA). To locate a tax site or schedule an appointment, tax filers can call 2-1-1, the United Way's free information and referral hotline.
